#### **Initiatives on SUCs PBB Guidelines**

- The **Commission on Higher Education** is the oversight agency of State Universities and Colleges.
- CHED designated its Office of Institutional Quality Assurance and Governance (OIQAG) to evaluate the accomplishments of SUCs.
- OIQAG conducted orientations on the 2016 PBB for SUCs on December 6, 2016 (Luzon Group) and December 7, 2016 (Visayas and Mindanao Group) in Quezon City.



#### **Initiatives on SUCs PBB Guidelines**

- The orientation included discussions on:
  - MC 2016-01 and MC 2016-02
  - List of consolidated 2016 indicators of SUCs from GAA 2016
  - Issues and concerns regarding the evaluation process of the 2016 PBB evaluation of accomplishments.
- 100 of the 112 SUCs (89%) attended the orientations.

  - One (1) excel file of the supporting documents (MFO 1-4 FORMS),
  - One (1) pdf file of the signed supporting documents (MFO 1-4 FORMS),
  - Scanned or pdf files of other supporting documents duly signed (e.g., Memorandum of Agreement, contracts, letters to other agencies).



### **Further Reminders for SUCs**

#### 2. Submit to AO25 Secretariat

- All forms and documents pertaining to PBB including ADDITIONAL SUPPORTING DOCUMENTS requested by CHED during the review process.
- 3. CHED **shall only review** documents forwarded by the AO25 Secretariat.



## **Further Reminders for SUCs**

- 4. For **appeals** to the Final Validation Results:
  - Address appeals to AO25 Technical Working Group
  - AO25 Secretariat shall duly endorse the appeals to CHED
  - CHED shall act upon the appeals
