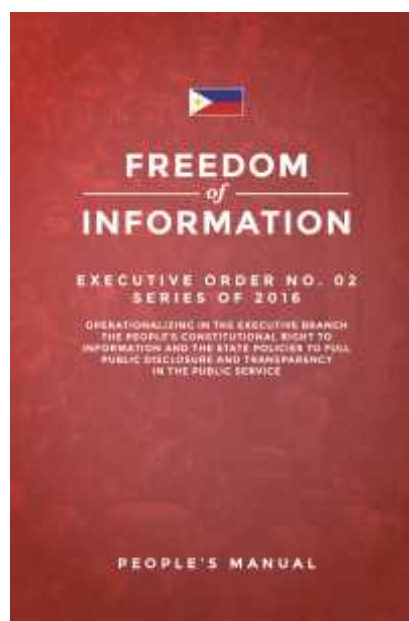
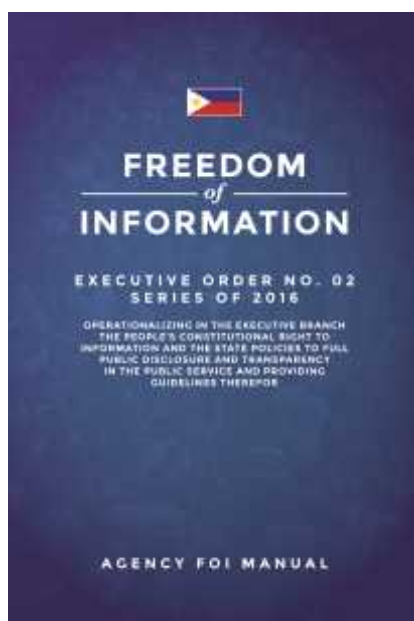

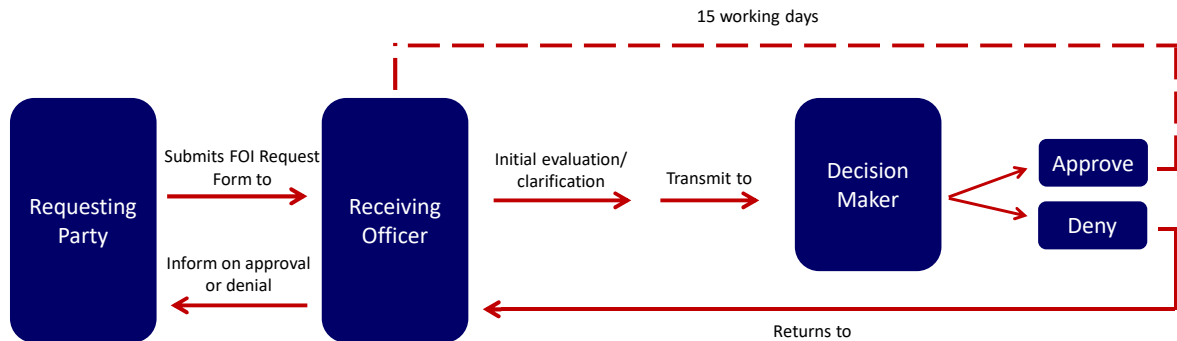

## Flowchart for an FOI request



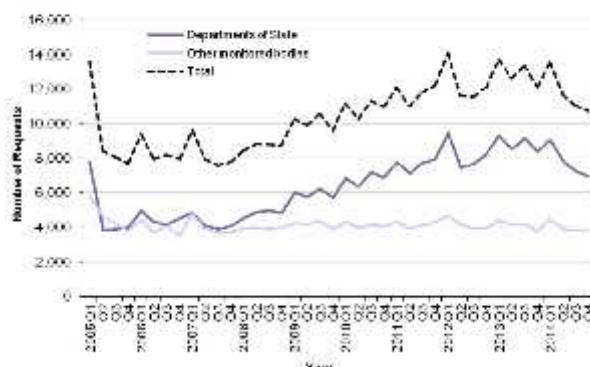

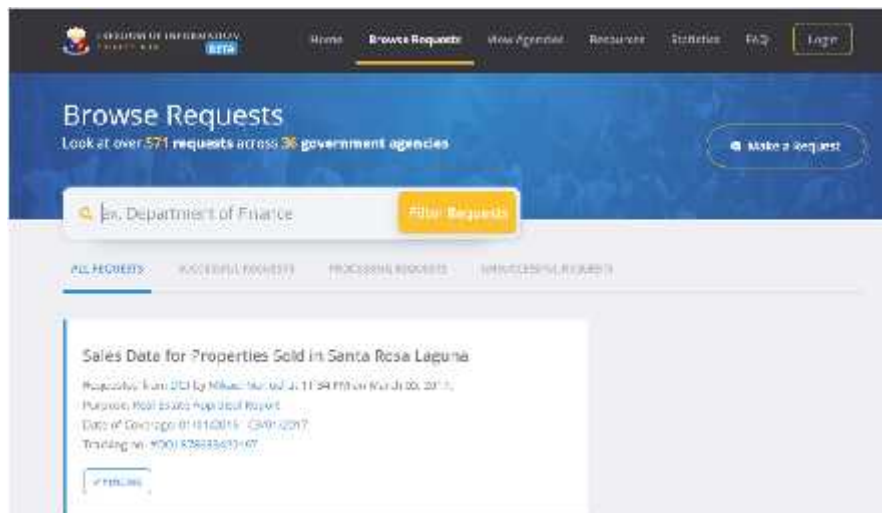

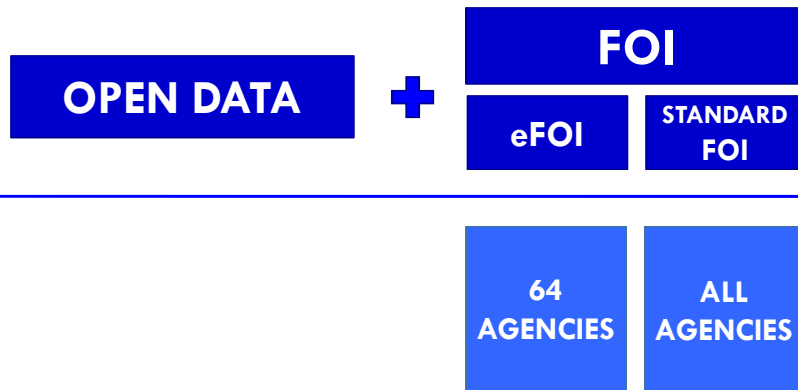
